9:00 a.m. – 2:30 p.m.**

Contest Rules

1. There will be no pre-registration and there will be no prize money. Ribbons will be awarded to 1st, 2nd and 3rd place winners. Ribbons may be picked up at the tent following judging on Tuesday, August 20th until 5:00 p.m. on Sunday, August 25th when the fair closes.
2. All entries are to be registered and received at the Agricultural Tent on Tuesday, August 20th (the day before the fair starts) from 9:00 a.m. to 2:30 p.m. Exhibitor's name may not appear on the entry, only on the exhibitor card. Judging will begin immediately at 3:00 p.m.
3. Exhibits must be called for by the exhibitor Sunday, August 25th at 5:00 p.m. Those exhibit's still present after 5:30 p.m. will be forfeited by the owner, and disposed of.
4. Any entries unfit to show will be disqualified.
5. After the exhibits are arranged, they will be under exclusive charge of the fair committee and not even the owner shall have the right to remove them until the exhibit is closed. The management may at any time remove an exhibit which is in bad condition.
6. A card containing the name and address of the exhibitor may be attached to the exhibit after it has been judged. No printed or written material advertising spray mixtures or implements of any kind will be allowed.
7. All classes are open to all exhibitors, but subject to above rules and regulations.

All entries must be grown this year in New Jersey, by the person who is exhibiting them.

APPLES

1. **All specimens to have stems attached and be free from serious insect and disease blemishes to qualify.**
2. **All varieties displayed in collection must be correctly named. Pins will be supplied so that cards with the variety name may be attached.**
3. **All single plate displays will be judged according to the following score card: form – 10; size – 10; color – 15; uniformity – 20; quality – 20; freedom from blemishes – 25; total – 100.**
4. **Five specimens of a variety are required in all plate displays including collection.**

CLASSES

APPLE

400. Honeycrisp

401. Gala- (any strain)

402. McIntosh (any strain)

403. Empire

404. Any other variety correctly named

CRAB APPLES

Ten specimens required.

405. Any variety correctly named

GRAPES

Two bunches are required for all displays in this division. Badly decayed or shattered bunches and inferior specimens will not qualify.

406. Any variety correctly named

PEARS

Five specimens of each variety are required for all exhibits. All specimens to have stems attached and be free from insect or disease blemishes. The scorecard for plate displays of apples will be used in judging pears.

407. Any European pear variety correctly named

408. Any Asian pear variety correctly named

PEACHES

Five specimens of each variety are required in all plate exhibits.

409. Any variety correctly named

PLUMS

European or Japanese

Five specimens

410. Plums, any variety correctly named
