GUIDELINES

The Hunterdon County 4-H & Agricultural Fair is proud to present the Hunterdon County Quilt Show. This quilt competition will be displayed at the Hunterdon County 4-H & Agricultural Fair being held at the South County Park, Ringoes, NJ, from August 22 - 26, 2018. Judges will evaluate all entries requesting to be judged. Ribbons will be awarded in all categories for first, second and third place. Rosettes will be awarded for Best of Show Quilts, Best of Show Overall, Best of Show Hand Quilted, Best of Show Machine Quilted, and Viewer's Choice. Please review the Entry Form for the various divisions and their definitions. **Please read the entry rules carefully.**

ALL entries **MUST** have been completed within the past two years and must not have been previously exhibited in this show.

ALL entries **MUST** be submitted in a pillowcase with a photo attached.

ALL entries **MUST** be clean, free of pins, pet hair, and smoke.

ALL entries **MUST** be constructed of fabric and quilted.

ALL entries **MUST** be labeled on the back of the quilt.

ALL labels **MUST** be temporarily covered with fabric or freezer paper for judging.

Due to limited space, winning entries will be displayed first. Each exhibitor will have at least one quilt on display.

AWARD: Rosettes and ribbons to all winners and certificates to all participants.

HOW TO ENTER CHECKLIST:

- Complete an entry form, one for **EACH** entry. Please print clearly.
- Label each entry on the back and cover it temporarily for judging with basted fabric or freezer paper.
- Place each entry in a pillowcase with your name, address and photo on each case.
- **DROP OFF LOCATION** - Bring all entries to the Hunterdon County 4-H Office, Route 12 County Complex, Building #2, (county library complex) Flemington, NJ, on Saturday, August 18 between 9:00 a.m. – 1:00 p.m.

JUDGING CRITERIA

Overall Appearance – The Quilt's condition of cleanliness, neatness, appearance and total presentation.

Visual Impact – Scale, placement, distinctiveness, use of color, originality, relationship of quilting design and relationship of the quilt borders to the body of the quilt.

Workmanship – Accuracy of piecing or appliqué, quality of stitching and quilting, binding, borders and top and bottom corners.

RETURN INSTRUCTIONS

All items must remain on display until the end of the fair. You **MUST** pick up your entries at the fair on **Sunday, August 26th between 5:30 – 6:00 p.m. Entry receipts must be presented at time of pick up. No quilts will be returned before 5:30 p.m.**
